### **NEW COVID-19 PHASE 3 (HEIGHTENED ALERT) SAFE MEASUREMENT MEASURES**

The Multi-Ministry Taskforce (MTF) announced via a press conference a list of tightened safe management measures (SMMs) which will be applicable from 19<sup>th</sup> July 2021 onwards to be implemented as follows:

Activities	Tightened SMM (From 19 July 2021)
Social gathering and Interactions	<ul style="list-style-type: none"> <li>Group sizes up to 5 pax</li> <li>Up to 5 unique household visitors a day</li> <li>2 social gatherings per day, whether to another household or in a public place</li> <li>Grandparents need not be included in the number of household visitors or social gatherings per day</li> </ul>
Sauna and Furobath	<ul style="list-style-type: none"> <li>Indoor mask-off activities in group sizes of up to <b>2 persons</b></li> </ul>
Outdoor barbeque pits	<ul style="list-style-type: none"> <li>All outdoor barbeque pits must be <b>closed till further notice.</b></li> </ul>
Indoor gymnasiums and Indoor fitness Studios	<ul style="list-style-type: none"> <li>Indoor mask-off activities in group sizes of up to <b>2 persons</b></li> </ul>
Outdoor exercise facilities and classes	<ul style="list-style-type: none"> <li>Occupancy limit of 1 person per 10 square metres of usable area or 30 persons, whichever is lower.</li> <li>Up to 30 persons per class subject to venue capacity limits.</li> <li><b>3 meters</b> between groups.</li> <li><b>2 meters</b> between individuals.</li> <li>Group sizes of up to <b>5 persons</b></li> </ul>
Tennis Courts	<ul style="list-style-type: none"> <li><b>5 person</b> per court (Maximum 1 guest)</li> </ul>

For your safety and as a precautionary measure, residents are also reminded to observe the safe management measures including the wearing of masks when they are not in their place of residence.

**We will not hesitate to report to BCA or the police if anyone is found not wearing masks and not adhering to the safe management measures.** Together, we all have a part to play in keeping COVID-19 at bay and protect ourselves and our loved ones.
