RE-OPENING OF CHILDREN'S WADING POOL ON 11TH SEPTEMBER 2023

1. With reference to our earlier circular of 26th August 2023, we are pleased to inform you that the management corporation has obtained the test reports for both water quality and equipment safety for the wading pool.
2. The newly upgraded wading pool will be re-opened on **11th September 2023**.
3. The wading pool equipment had been inspected by an independent Certified Safety Inspector for compliance with the required Standard for Play Equipment for Public Use.
4. The Condo Management would like to remind all users of the following Play and Safety Advisory for observance and compliance:

Important Play & Safety Advisory to Users:

- ❖ **Children must wear proper clothing when playing at the waterplay area. Clothing with dangling strings is prohibited.**
- ❖ **Parents or adults must always supervise and guide their children when using the play equipment.**
- ❖ **For the safety of all users, each equipment is limited to a maximum of 4 children at anyone time to avoid overcrowding.**
- ❖ **Please inform the Condo Management to report damaged or faulty equipment immediately.**
- ❖ **The play equipment is designed to cater for different age groups of children. Please see the safety guidelines overleaf.**
- ❖ **The Management Corporation shall not be responsible for any injury or property damage resulting from the use of the equipment.**
