

Update: 11 August 2021



Transition Out of Phase 2 (Heightened Alert): Indoor Facilities

Following the latest Government Advisory and Management’s precautionary measures, whilst keeping in mind the well-being and safety of all our residents, we would like to update and inform residents on the usage of Indoor Facilities for Gym, Steam Rooms, Function Room and Reading Room.

Function Room	Open for Usage from 11 August 2021	<p>Limit to 5 persons at any time, who are <u>Fully Vaccinated and children 12 & below who are ineligible to be vaccinated</u></p>	<ul style="list-style-type: none"> ❖ Only Fully Vaccinated persons and children 12 years old and below who are ineligible to be vaccinated. • Ensure Safe Distancing of at least 1 metre. • Please Wear your Mask.
Reading Room	Open for Usage from 11 August 2021	<p>Limit to 2 persons at any time.</p>	<ul style="list-style-type: none"> • Ensure Safe Distancing of at least 1 metre. • Please Wear your Mask.

Please note the following Covid-19 Safe Management Measures:

- An individual is considered fully vaccinated two weeks after he or she has received two doses of Pfizer-BioNTech/ Comirnaty, Moderna, or any WHO EUL vaccines.
- **Please bring along your vaccinated reports via phone app or certificate at all times when using the Gym, Steam Rooms and Function Room that are only open to fully vaccinated individuals for our verification. Spot checks on your vaccination status will be carried out by the security / facility officers. Any individual who failed to show the proof of vaccination will not be permitted to use the facilities.**
- Social gatherings of up to any 5 persons are allowed. Each household may receive up to only 5 distinct visitors per day. Unvaccinated individuals should remain in groups of no more than 2 persons, to reduce the likelihood of transmission. Individuals should keep to no more than 2 social gatherings per day.

The authorities will be conducting inspections and enforcement action(s) under the COVID-19 (Temporary Measures) Act and the Infectious Diseases Act will be taken against individuals who fail to comply with safe management measures. In addition, we will need to close the facility for use.

We seek your kind understanding, patience and cooperation with the government advisories and all the measures in respect of the use of the common facilities.
