NEW COVID-19 MEASURES - PROTECT OUR FAMILY MEMBERS AND THE PEOPLE AROUND US

Given the latest sweeping measures to contain the coronavirus outbreak in Singapore announced on Tuesday 24 March 2020 by Government.

The Management has implemented the followings measures with effect from Tuesday, 31 March 2020:

1. Closing of indoor facilities (Gym, Karaoke Room, Aerobics Room, Reading Lounge, Study Room, Furobath and Sauna) **till further notice.**
2. Refunds will be made for booking fees received.
3. Groups must **not exceed 10 people** for Outdoor activities with safe distancing measures
4. **Swimming pools will remain open with daily chlorine level testing.**
5. At Management Office, safe distancing measures (1-metre) will be applied for queue in making applications and payments. Only one (1) resident can be at the counter at any one time to make application or payment.
6. We strongly urge to pay maintenance / sinking fund via Internet banking or deposit cheque at Management's letterbox at Tower A #01-01 to avoid close contact.
7. **The pool loungers and other common areas' furniture will be placed at 1-metre distance.**
8. Residents who are issued with the following notices are to be socially responsible and be confined to their homes and not to go out to the common areas within the estate. The Management shall not hesitate to report such defaulters to the relevant authorities.

Resident who are issued with
a) Stay Home Notice (SHN)
b) Quarantine Order (QO)

DO NOT LEAVE YOUR HOME.
Offenders could be face up to \$10,000 fine
or up to 6 months jail or both.

9. For Residents who are issued with Leave of Absence (LOA) - recommended to stay at home except going out to attend to essential matters.
10. Those residents who have been issued the above notices, the Management will appreciate if you can inform Management Office @ 6874 5410 in order for us to arrange for increased cleaning frequencies of the block levels.
